


Figure 1. Power Dissipation vs. Ambient Temperature




Figure 3. Relative Radiant Sensitivity vs. Angular Displacement




Figure 2. Forward Current vs. Ambient Temperature




Figure 4. Forward Current vs. Forward Voltage




Figure 5. Rel. Luminous Flux vs. Ambient Temperature





Figure 6. Relative Luminous Flux vs. Forward Current

### **PACKAGE DIMENSIONS** in millimeters







Figure 7. Relative Intensity vs. Wavelength
