




Description

The ACPL-312T device contains an AlGaAs LED. The LED is optically coupled to an integrated circuit with a power output stage. This automotive optocoupler is ideally suited for driving power IGBTs and MOSFETs used in automotive motor control inverter and DC-DC converters applications. The high operating voltage range of the output stage provides the drive voltages required by gate controlled devices. The voltage and current supplied by these optocouplers make them ideally suited for directly driving IGBTs with ratings up to 1200 V/100 A. For IGBTs with higher ratings, the ACPL-312T series can be used to drive a discrete power stage which drives the IGBT gate.





ACPL-312T-000E Standard DIP Package









All Avago data sheets report the creepage and clearance inherent to the optocoupler component itself. These dimensions are needed as a starting point for the equipment designer when determining the circuit insulation requirements. However, once mounted on a printed circuit board, minimum creepage and clearance requirements must be met as specified for individual equipment standards. For creepage, the shortest distance path along the

surface of a printed circuit board between the solder fillets of the input and output leads must be considered. There are recommended techniques such as grooves and ribs which may be used on a printed circuit board to achieve desired creepage and clearances. Creepage and clearance distances will also change depending on factors such as pollution degree and insulation level.



Figure 1. V_{OH} vs. temperature.




Figure 2. $I_{\mbox{\scriptsize OH}}$ vs. temperature.




Figure 3. V_{OH} vs. I_{OH} .




Figure 4. V_{OL} vs. temperature.




Figure 5. I_{OL} vs. temperature.

Figure 6. V_{0L} vs. I_{0L} .




Figure 7. I_{CC} vs. temperature.




Figure 9. I_{FLH} vs. temperature.




Figure 11. Propagation delay vs. I_F.




Figure 8. I_{CC} vs. $V_{\text{CC}}.$




Figure 10. Propagation delay vs. V_{CC}.




Figure 12. Propagation delay vs. temperature.





Figure 13. Propagation delay vs. Rg.

Figure 15. Transfer characteristics.




Figure 14. Propagation delay vs. Cg.





Figure 16. Input current vs. forward voltage.








Figure 18. I_{OL} Test circuit.




Figure 19. V_{OH} Test circuit.




Figure 20. $\ensuremath{\text{V}_{\text{OL}}}$ Test circuit.




Figure 21. I_{FLH} Test circuit.




Figure 22. UVLO test circuit.




Figure 23. t_{PLH} , t_{PHL} , t_{r} , and tf test circuit and waveforms.




Figure 24. CMR test circuit and waveforms.

Applications Information

Eliminating Negative IGBT Gate Drive ACPL-312T




Figure 25. Recommended LED drive and application circuit.

To keep the IGBT firmly off, the ACPL-312T has a very low maximum V_{OL} specification of 0.5 V. The ACPL-312T realizesthis very low V_{OL} by using a DMOS transistor with 1 Ω (typical) on resistance in its pull down circuit. When the ACPL-312T is in the low state, the IGBT gate is shorted to the emitter by Rg + 1 Ω . Minimizing Rg and the lead inductance from the ACPL-312T to the IGBT gate and emitter (possibly by mounting the ACPL-312T on a small PC board directly above the IGBT) can eliminate the need for nega-

tive IGBT gate drive in many applications as shown in Figure 25. Care should be taken with such a PC board design to avoid routing the IGBT collector or emitter traces close to the ACPL-312T input as this can result in unwanted coupling of transient signals into the ACPL-312T and degrade performance. (If the IGBT drain must be routed near the ACPL-312T input, then the LED should be reverse-biased when in the off state, to prevent the transient signals coupled from the IGBT drain from turning on the ACPL-312T).

Selecting the Gate Resistor (Rg) to Minimize IGBT Switching Losses.




Figure 26. ACPL-312T typical application circuit with negative IGBT gate drive.

Step 1: Calculate Rg Minimum from the I_{OL} Peak Specification. The IGBT and Rg in Figure 26 can be analyzed as a simple RC circuit with a voltage supplied by the HCPL-3120.

$$\begin{split} R_g & \geq \frac{(V_{CC} - V_{EE} - V_{OL})}{I_{OLPEAK}} = \frac{(V_{CC} - V_{EE} - 2V)}{I_{OLPEAK}} \\ & = \frac{(15 + 5 - 2)}{2.5A} \quad R_g = 7.2\Omega \cong 8\Omega \end{split}$$

The V_{OL} value of 2 V in the previous equation is a conservative value of VOL at the peak current of 2.5A (see Figure 6). At lower Rg values the voltage supplied by the ACPL-312T is not an ideal voltage step. This results in lower peak currents (more margin) than predicted by this analysis. When negative gate drive is not used VEE in the previous equation is equal to zero volts.

Step 2: Check the ACPL-312T Power Dissipation and Increase Rg if Necessary.

The ACPL-312T total power dissipation (P_T) is equal to the sum of the emitter power (P_E) and the output power (P_O):

The value of 4.25 mA for I_{CC} in the previous equation was obtained by derating the I_{CC} max of 5 mA (which occurs at -40°C) to I_{CC} max at 125C (see Figure 7). Since P_O for this case is greater than $P_{O(MAX)}$, R_g must be increased to reduce the ACPL-312T power dissipation.




Figure 27. Energy dissipated in the ACPL-312T for each IGBT switching cycle.

Thermal Model

The steady state thermal model for the ACPL-312T is shown in Figure 28. The thermal resistance values given in this model can be used to calculate the temperatures at each node for a given operating condition. As shown by the model, all heat generated flows through θ_{CA} which raises the case temperature TC accordingly. The value of θ_{CA} depends on the conditions of the board design and is, therefore, determined by the designer. The value of $\theta_{CA} = 83^{\circ}\text{C/W}$ was obtained from thermal measurements using a 2.5 x 2.5 inch PC board, with small traces (no ground plane), a single ACPL-312T soldered into the center of the board and still air. The absolute maximum power dissipation de-rating specifications assume a θ_{CA} value of 83°C/W. From the thermal mode in Figure 28 the LED and detector IC junction temperatures can be expressed as:



LED Drive Circuit Considerations for Ultra High CMR Performance.




Figure 29. Optocoupler input to output capacitance model for unshielded optocouplers.




Figure 30. Optocoupler input to output capacitance model for shielded optocouplers.

Without a detector shield, the dominant cause of optocoupler CMR failure is capacitive coupling from the input side of the optocoupler, through the package, to the detector IC as shown in Figure 29. The ACPL-312T improves CMR performance by using a detector IC with an optically transparent Faraday shield, which diverts the capacitively coupled current away from the sensitive IC circuitry. However, this shield does not eliminate the capacitive coupling between the LED and optocoupler pins 5-8 as shown in Figure 30. This capacitive coupling causes perturbations in the LED current during common mode transients and becomes the major source of CMR failures for a shielded optocoupler. The main design objective of a high CMR LED drive circuit becomes keeping the LED in the proper state (on or off) during common mode transients. For example, the recommended application circuit (Figure 25), can achieve 25 kV/µs CMR while minimizing component complexity. Techniques to keep the LED in the proper state are discussed in the next two sections.

CMR with the LED On (CMRH).




Figure 31. Equivalent circuit for figure 25 during common mode transient.




Figure 33. Recommended LED drive circuit for ultra-high CMR.

A high CMR LED drive circuit must keep the LED on during common mode transients. This is achieved by overdriving the LED current beyond the input threshold so that it is not pulled below the threshold during a transient. A minimum LED current of 10 mA provides adequate margin over the maximum IFLH of 5 mA to achieve 25 kV/ μs CMR. CMR with the LED Off (CMRL). A high CMR LED drive circuit must keep the LED off (V $_F \leq V_{F(OFF)}$) during common mode transients. For example, during a -dV $_{cm}$ /dt transient in Figure 31, the current flowing through C $_{LEDP}$ also flows through the R_{SAT} and V_{SAT} of the logic gate. As

long as the low state voltage developed across the logic gate is less than $V_{F(OFF)}$, the LED will remain off and no common mode failure will occur. The open collector drive circuit, shown in Figure 32, cannot keep the LED off during a $+dV_{cm}/dt$ transient, since all the current flowing through C_{LEDN} must be supplied by the LED, and it is not recommended for applications requiring ultra high CMRL performance. Figure 33 is an alternative drive circuit which, like the recommended application circuit (Figure 25), does achieve ultra high CMR performance by shunting the LED in the off state.

Figure 32. Not recommended open collector drive circuit.

Under Voltage Lockout Feature.

The ACPL-312T contains an under voltage lockout (UVLO) feature that is designed to protect the IGBT under fault conditions which cause the ACPL-312T supply voltage (equivalent to the fully-charged IGBT gate voltage) to drop below a level necessary to keep the IGBT in a low resistance state. When the ACPL-312T output is in the high state and the supply voltage drops below the ACPL-312T V_{UVLO} — threshold (9.5 < V_{UVLO} — < 12.0) the optocoupler output will go into the low state with a typical delay, UVLO Turn Off Delay, of 0.6 μ s. When the ACPL-312T output is in the low state and the supply voltage rises above the ACPL-312T V_{UVLO} + threshold (11.0 < V_{UVLO} + < 13.5) the optocoupler output will go into the high state (assumes LED is "ON") with a typical delay, UVLO Turn On Delay of 0.8 μ s.





Figure 34. Under voltage lock out.

ARE TAKEN AT THE SAME TEMPERATURE AND TEST CONDITIONS.


Figure 35. Minimum LED skew for zero dead time.

Dead Time and Propagation Delay Specifications

The ACPL-312T includes a Propagation Delay Difference (PDD) specification intended to help designers minimize "dead time" in their power inverter designs. Dead time is the time period during which both the high and low side power transistors (Q1 and Q2 in Figure 25) are off. Any overlap in Q1 and Q2 conduction will result in large currents flowing through the power devices between the high and low voltage motor rails.

To minimize dead time in a given design, the turn on of LED2 should be delayed (relative to the turn off of LED1) so that under worst-case conditions, transistor Q1 has just turned off when transistor Q2 turns on, as shown in Figure 35. The amount of delay necessary to achieve this condition is equal to the maximum value of the propagation delay difference specification, PDD_{MAX}, which is specified to be 350 ns over the operating temperature range of -40°C to 125°C. Delaying the LED signal by the maximum propagation delay difference ensures that the minimum dead time is zero, but it does not tell a designer what the maximum dead time will be. The maximum dead time is equivalent to the difference between the maximum and minimum propagation delay difference specifications as shown in Figure 36. The maximum dead time for the AC-PL-312T is 700 ns (= 350 ns - (-350 ns)) over an operating temperature range of -40°C to 125°C.

Note that the propagation delays used to calculate PDD and dead time are taken at equal temperatures and test conditions since the optocouplers under consideration are typically mounted in close proximity to each other and are switching identical IGBTs.




Figure 37. Thermal derating curve, dependence of safety limiting value with case temperature per IEC/EN/DIN EN 60747-5-2.
